**Resolution Process Summary:**

- A Lincoln County and registered T.B. Scott Free Library card holder may make a statement of concern regarding materials in the Library's collection. Requests from groups or organizations will not be considered.
- This request must be submitted in writing using the Library's Statement of Concern About Library Resources" form.
- After the request is received, the Director will review the concerns and provide a written response to the community member
- If dissatisfied with the response, the community member may request review by the Library Board of Trustees. Please note that, at this point, the "Statement of Concern About Library Resources" form becomes a public document and the person(s) completing this form waive(s) their right to anonymity under Section 43.30, Wis.Stats.
